Melt temperature220 - 260 °CHolding pressure200 - 500 bar Maximum to avoid sink marksMold temperature20 - 40 °CInjection speedHighShrinkage1 - 2 % depending on wall thickness and molding parameters

Storage and Handling

Luban HP2100N should be stored in well ventilate area during handling or processing of to prevent accumulation of dust and fumes. Avoid contact with strong oxidizers, excessive heat, sparks or open flame as this could well speed up alteration and consequently loss of quality of the material in which could lead to unforeseen dangers. The bags must be protected from direct sunlight and should be stored in shaded and completely dry area for good processing.
